Commercial distribution through retail chains or food stores. For home consumption, addressed to adult people and to be used with compatible coffee machines. It is recommended to be prepared in a 180 ml cup.

Preservation: Store in a cool, dry place. Keep away from direct heat and strong smell sources. Packed in sealed capsules in protective atmosphere which allow an optimal preservation till its use.

Preparation guidelines: Follow coffee machine instructions and recommended dose
