

Declaration of Conformity

Declaration applies to containers regardless of their dimensions made of **R-PET transparent** film.

Film consists of the recycled materials with a functional barrier that prevents migration of the recycled material to the food, made of the following composition: PET granules, Antyblock, Optical brightener,

The containers covered by the declaration are intended for contact with non-alcoholic and alcoholic drinks with an alcohol content not exceeding 6% by volume, including: pure drinks, juices, nectars, beer, sauces, dips, dressings.

The company KGL S.A. declares that manufactured products are comply with the provisions regarding the products and materials intended to come in contact with food in terms of:

Compliance with the EU legislation:

1. European Regulation **No 1935/2004/CE** - Regulation on materials and articles intended to come in contact with food and repealing Directives 80/590/EEC and 89/109/EEC
2. European Directive **No 2023/2006/EC** - Regulation on good manufacturing practice for materials and articles intended to come into contact with food amended by Commission Regulation (EC) No. 282/2008

6. Act of 25 August 2006 on the safety of food and nutrition (Journal of Laws of 2006 No. 136, item 914, as amended)

Monomers and substances in our products are listed in the lists of substances whose use is permitted according to the **10/2011/EU**.



Based on the declaration of raw material producers, we declare compliance with the Regulation of the European Parliament and Council Regulation (EC) No. 1272/2008 of 16 December 2008 on classification, labeling and packaging of substances and mixtures (as amended), Regulation (EC) No. 1907 / 2006 of the European Parliament and of the Council of December 18, 2006. on the Registration, Evaluation, Authorization and Restriction of Chemicals (REACH) (as amended), complies with the requirements of the European Resolution AP (89)1 on the use of colorants in plastic articles coming into contact with food.

In accordance with the provisions of Commission Regulation (EU) No 10/2011 of 14 January 2011 on plastic materials and products intended to come into contact with food, **the level of global migration does not exceed 10 mg / dm²** for food simulants:

- 10% ethanol (10 days at a temperature of 40⁰C) 0,5 ± 0,1 mg/dm²
- 3% acetic acid (10 days at a temperature of 40⁰C) 0,5 ± 0,1mg/dm²
- 95% ethanol (10 days at a temperature of 40⁰C) 0,6 ± 0,1 mg/dm²

The following conditions were simulated for global migration studies: heating up to 70 °C for up to 2 hours, or heating up to 100 °C for up to 15 minutes.

Sensory analysis - assessment of smell and taste:

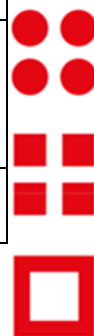
— water (10 days at 40 °C) - Smell -0 -Taste – 0 *

*explanation: 0 – undetectable; 1 – barely perceptible; 2 –weak ; 3 – marked ; 4 – strong

Calculations were carried out assuming 1kg of food coming into contact with 6 dm² of product.

Based on the declarations of producers of raw materials, we inform that the above product contains certain substances and additives, which are assigned specific migration limits (SML).

Storage conditions:

Storage in indoor warehouse, free from dust, dry, ventilated at ambient temperature. Additional conditions and recommendations included in the technical specification of individual products.

Processing time and temperature:

- period of less than 15 minutes between 30°C and 40°C

Restrictions in use:

- goods are not intended for cooking and sterilization,
- goods cannot be used as a toy,
- goods cannot be eaten,
- goods are not intended to be heated in microwave and oven.

- hazardous substances and mixtures marked in the Regulation of the European Parliament and of the Council (EC) No 1272/2008 of 16 December 2008 on classification, labeling and packaging of substances and mixtures, amending and repealing Directives 67/548 / EEC and 1999 / 45 / EC and amending Regulation (EC) No 1907/2006.

Declaration refers to raw material composition specified at the outset and applies for each delivery made of this composition.
